Harald Walach, Jahrgang 1957, promovierte in klinischer Psychologie und Wissenschaftstheorie und war Professor an der Medizinischen Universität Poznan, Polen, sowie Gastprofessor im Department Psychologie der Universität Witten/Herdecke. Seine Forschungsschwerpunkte sind angewandte Forschungsmethodik mit speziellem Blick auf die komplementärmedizinischen Verfahren; Meditation, Bewusstsein und Gesundheit; Selbstheilung und Placeboeffekte. Er ist Autor von mehr als 300 wissenschaftlichen Artikeln, Buchkapiteln und zahlreichen Büchern. Er gehört zu den 5 Promille der weltweit meistzitierten Autoren.
